Attention

For international students we have [American Government Law and Culture](#) class which is only available in 2nd semester (January to July) and the seminars of the program [Master in Common Law & Comparative Law](#), which as seminars have a strong variability in dates. Such M2 seminars are not always offered during regular Licence and Master students calendar/schedules. They can be scheduled during regular exams' period or even on regular holidays dates. These conditions make us limit the offer for academic exchange students to a maximum of 3 choices among classes and seminars taught in English for international exchange students by semester.

Under these conditions it's important to specify that for the moment we cannot then do not assure a whole and only English taught classes program (semester nor year) for international students.

Once stated that we do not assure a whole and only English taught courses program for international students; it's mandatory for you to have and grant at least a B2 French level certificate.

Also consider that University of Paris offers free language courses at the Language Centre (Maison des langues) for all local and international registered students.
